CRITERION I – CURRICULAR ASPECTS

1.1 – Curriculum Planning and Implementation

1.1.1 – Institution has the mechanism for well planned curriculum delivery and documentation. Explain in 500 words

The college follows all the instructions regarding syllabus prepared by HP University Shimla. However, flexibility of options available under CBCS are offered to the students and accordingly displayed on the college website. In a decentralised manner, various committees as per the staff council engaged in finalising the modalities of various courses such as Elective, skill Enhancement, General Interest & Hobby Courses and Discipline specific Courses that a student opt for. The Orientation Programme is conducted for new admissions to the first year under graduate programme and students of all streams are briefed about the courses offered by each department. The entire selection process is duly documented and records are shared with Administration. Students can express their grievances online as well as in person. A Grievance committee is in place for redressal of complaints of students. At the beginning of each semester, Teacher-in-Charge of each department holds a meeting to finalise the courses taught by individual teachers as per their expertise and interest. Time Table is finalized in collaboration with departments as well as the college Time-Table Committee as per the university guidelines. The teachers follow the curriculum and teach in various innovative and engaging methods involving the latest cutting edge educational technologies that the college provides. For assessment and documentation of students, a variety of methods are used in addition to the End- Semester Examination that the university conducts. Students in college are expected to go through a Continuous Comprehensive Assessment programme designed to test their educational, moral and extra curricular depths. Academic knowledge of the students is evaluated through Mid -Semester Examinations, project reports, presentations, term papers and assignments. Each student is encouraged to be part of any Sports and Extracurricular activities conducted, following the HP University Sports and Curricular activity calender, such as, CSCA Cultural function, HPU Youth Festivals, Red Cross Society, Red Ribbon Club, NCC, NSS, Eco Club, Rover and Rangers etc. Staff Advisors of each society are duly selected by the staff council of the college. Through these activities, we develop the intellectual as well as creative skills of our students and also encourage them to contribute towards community service. Participation in academic or cultural activities are well documented and the results displayed regularly on the college website. Regular lectures/seminars are organized by different departments in which eminent speakers are invited to deliver talks and interact with students. Regular meetings with CSCA executives and PTA are held to address any critical/sensitive issues being faced by the students which could prove to be a hindrance to their overall development. Counselling for selection of options, career choices and personal issues is regularly done.

Feedback is a regular feature of the college and is obtained from students ,parents ,teachers and alumni. Then the feedback is duly analyzed at upper management level and apt action is taken. Structured feedback is not obtained from stakeholders. In practice, we do organize PTA meetings two or three times in an academic year, in which problems or queries of parents are addressed. The college administration works in collaboration with the PTA in the interests of the students. We have CSCA, a student association consisting of representatives from all departments to communicate any type of problems of the students to

college authorities. CSCA Executive includes senior teachers as advisors and the Principal as the Chairperson/ Chief Advisor. All issues pertaining to students which are put forward by CSCA are resolved on priority basis. Moreover, each UG class has Class Representatives and PG class has Department Representatives which serve as a 'bridge' between the students and teachers and help in assessing and addressing the needs of students. The college also has Career Guidance and Counseling Cell that is also a systematic way of getting academic, professional as well as personal feedback of the students. Teaching is a constantly evolving process and a teacher continuously hones his/her skills throughout the career. This process is helped by getting an honest feedback from students as to what a teacher needs to do better to connect with the class more effectively. At our college, we promote our teachers to engage the class by letting them arrive at a conclusion rather than supplying them with a readymade conclusion. Through the help of feedbacks that we have received from students and teachers over the years, we have realized that the aim of teaching, especially at college level, is not just to make the students understand difficult concepts, but to enable them to think critically and expand their horizon and their intellect and we are constantly in the process of doing this. With the help of feedbacks we have also realized the expectations that our students have regarding the infrastructure of the departments and we are in the process of delivering on them. We have provided computer facilities to various departments to help our students receive the most recent technological advancements in their fields and this initiative has been very helpful for the students who could not afford personal laptops for their academic works. Finally, our strong alumni network mentors our students to choose and succeed in their preferred field. The college is having a registered Alumni association and the President of OSA is conveyed time to time regarding the major events of the college. Their valuable suggestions are taken into consideration for the improvement of the institution.

2.5.2 – Reforms initiated on Continuous Internal Evaluation(CIE) system at the institutional level (250 words)

Reforms in Continuous Internal Evaluation(CIE) of the students at the institutional level is based on Continuous Comprehensive Assessment (CCA). The CCA based on different parameters i.e, out of the reserved 30 marks of CCA, 15 marks are awarded on the basis of Minor Test. Minor Test is to be conducted after 48 teaching days (8 weeks) of each semester course and 10 Marks on the basis of assignments, seminars, quiz, presentation and related activities and 5 marks on the basis of Classroom Attendance i.e.,Lectures /Tutorials/Practical. In addition to said assignments the institution conducts Unit wise class tests, Tutorials, Student centric learning programmes, projects and practical sessions etc. to evaluate the performance of students from time to time. 70 marks in each course are reserved for End Semester Examination conducted by the university after covering the whole syllabus. The H.P. University has changed the End Semester Examination system into Annual pattern from the Academic session 2018..19. In Annual pattern/ system the CCA parameter has been changed i.e., out of 30 Marks, 10 marks is awarded through Minor Test which is conducted after covering 40 percent of syllabus and 5 Marks awarded through Class Test conducted after covering 70 percent of syllabus and 10 Marks on the basis of assignments, seminars, quiz, presentation, general behaviour of the students and cocurricular related activities and 5 marks on the basis class attendance. Annual Examination of 70 Marks conducted by the university after covering the whole syllabus usually held in the Months of March and April every year.

Academic calender is prepared by Directorate of Higher Education Himachal Pradesh in consultation with H P University Shimla and is implemented as such in affiliated colleges.Sports and cultural activity Calender is prepared by H P University in consultation with all affiliated colleges of University. One of the best practices of the institution is its sense of community responsibility. With a motive to create the consciousness of valuing voluntary services, the institute targets to inculcate in the young minds the spirit to save or change the life of an unknown person or sector. Keeping this in view, the institute attempts to make its students thoughtful about the social causes.

One step taken towards this direction is creating an awareness among the students towards voluntary blood donation. Thus, the institute targets to create an awareness of indispensable voluntary donation of blood at crucial times to save lives. It is realized that the youth must understand the significance of voluntary proclivity of blood donation. With this objective ahead, the institute organizes blood donation camps in the premises. Students enthusiastically come forward to donate their blood to the needy in regular intervals. The college organizes blood donation camps and campaigns in collaboration with the voluntary social service organizations like Red Cross Society. Apart from this, the college NCC and NSS units organize Blood Donation Camps. The volunteers of these units maintain a list of Blood donors with their blood groups. Even the local government hospital personnel's approach the volunteers whenever blood is required in an emergency. Many a time, needy persons or their family contacts the volunteers through some source and every time they are helped out. The staff of the institute also participates in such camps. This kind of healthy practice motivates the other students also. One of the many other good practices is making every possible attempt to maintain a clean and a lush green campus. The institute is determined to make its premises green and pollution free. To attain this objective, environmental conscious administration, and the students of the college look after the environment carefully. Every year, during rainy season, the students and the faculty members celebrate "Van Mahotsava" by planting saplings in the campus as well as at the forest areas allocated by the department of Forest. The years old Peepal tree enhances the serenity and peacefulness of the environment. A platform has been raised around the tree and the benches have been put under this tree for the students and the visitors. The dust bins have been put at different places separately for dry and wet waste. The incinerators have been installed in girls' toilets to dispose off the sanitary pads. The boards with the instructions to maintain cleanliness in the campus have been placed at different locations in the campus. The faculty members and the students actively participate in the movements like "Swachh Bharat Abhiyaan".

7.3 – Institutional Distinctiveness

Institutional Distinctiveness Following the Vallabhian spirit the college imparts knowledge, values and social responsibility to its students. Being one of the oldest colleges of Himachal Pradesh, Vallabh Government College Mandi has long been recognised as a premier institute which provides opportunity for gaining quality education to the rural and urban residents of the state. Keeping in mind the vision of the college to provide holistic development to all the students (with a thrust on grooming the personalities of students coming from rural and far-flung areas) the UGC CBCS was completely transformed in 2016- 17 which brought the college at par with the syllabus and system followed by Universities at All-India basis. The teaching and non-teaching staff of the college worked hard to get it implemented. The UGC CBCS (Choice Based Credit System) provided the students the opportunity to choose courses from the prescribed courses electing core skills-based, elective/minor courses. The CBCS allowed the students to choose inter-disciplinary, inter-disciplinary courses, skill-oriented papers according to interest and aptitude of the students. Education became student- centric. It also offered the students the flexibility to study at different times and different institutions to complete one course. New syllabus was adopted and new guidelines were adhered to. All this comprised local need based priority area to groom our students for job markets as well as for higher studies and research. This has, in turn, contributed a great deal to accomplish institutional vision of grooming personalities, providing employability skills and thereby contributing to the society. Coming at par with other Universities of the country was also commensurate with the Vallabhian vision of Ek Bharat, Shreshth Bharat.

8.Future Plans of Actions for Next Academic Year

1. The institute is determined to keep the premises clean and green as well as to conserve energy. With this purpose ahead, the institute has decided to install solar panels in Old Girls' Hostel. 2. It has also been realized that for the purpose of hygiene and comfort of the girl students, as many of them come from far-flung areas, incinerators are urgently required in the girls' toilets. Thus the decision has been taken in the IQAC meeting to install sanitary pad vending machines in girls' hostel and incinerators in the girls' toilets. The plan is to install both the machines in the running session. 3. The administration has always been conscious about any problems being faced by the students and in making attempts to eliminate them at the earliest. The old wiring system in the Old Girls' Hostel is becoming problematic day-by-day. So it has also been planned in the IQAC meeting to do the rewiring in the hostel on a priority basis. 4. Two more difficulties that students are facing for some time are i.) the deteriorating condition of the college canteen and ii.) the nuisance of monkeys in and around the zoology department. Sensing the urgency of the situation, it has been planned to renovate the canteen and to fence the department of zoology. 5. IT lab of the institute is a valuable asset for the students. The students avail this facility zealously. Observing the increasing interest of the students, it has been planned to increase the number of computers in IT lab. 6. Though the institute buys new furniture time-to -time, still it has been noticed that a good number of old furniture is lying damaged and thus unused, though it can be utilized if repaired. With the vision of optimal use of available resources, the IQAC has planned to repair this furniture and make it usable. 7. Units of NSS,

NCC, Rovers and Rangers, Eco Club and Red Cross Society are doing well and are involved in a number social activities. But it has been felt that the common students should also become more aware of their societal role. Thus, it has been planned to enhance the extension activities like plantation of trees, blood donation camps, cleaning of local water resources etc
