1. They will be paid a fixed contractual amount @ Rs. 12,360/- (Rupees Twelve Thousand Three Hundred Sixty) only per month.
2. The Service of the contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory. In case the contract appointee is not satisfied with the termination orders issued by the Appointing Authority, he/she may prefer an appeal before the Appellate Authority who shall be higher in rank to the

Appointing Authority, within a period of 45 days, from the date on which a copy of termination orders is delivered.

3. They will be entitled for one day's casual leave after putting in one month service. A female contract appointee with less than two surviving children may be granted maternity leave for 180 day. 5. They will submit a certificate of his/her fitness from the Zonal Hospital.
